Therefore, the candidate should carefully check, if the posts applied for by him/her are correctly mentioned in the Admit Card. In case of any discrepancy, it should immediately be reported to NTA at wbharatirec@nta.ac.in.
- This Admit Card is issued online provisionally to the Candidates, subject to the fulfilment of the eligibility conditions.
