### Procedure for Challenge of Answer Key

1. Please go to website <https://vbharatirec.nta.ac.in/>
2. Login with your **Application Number and Date of Birth** and enter Security Pin as displayed and Submit.
3. Click on 'Click here to View your Responses' link to view your response sheet.
4. Click on 'Challenge of Questions' tab for challenging the questions.
5. You will see the Question IDs in sequential order.
6. The ID next to the question under the column 'Correct Option' stands for the most appropriate Answer Key to be used by NTA.
7. If you wish to challenge this option, you may use any one or more of the Option IDs given in the next four columns by clicking the check box.
8. You may upload supporting documents in the field 'Choose File' and upload (all documents to be put in a single pdf/jpg file).
9. After clicking your desired option, click on 'Challenge Question' and move to the next screen.
10. You will see a display of all the Option IDs you have challenged and if any changes required, candidate can click on Edit/Add challenge Questions Click on 'Save your Claim and Pay Fee Finally'.
11. Click on 'Continue and Pay Fee Finally'.
12. Select Mode of Payment and Pay a non-refundable processing fee @ ₹ 200/- for each question challenged. Make payment through Credit Card/ Debit Card/Net Banking/UPI.
