## Procedure for Challenge of Answer Key

- 1. Please go to website <u>https://vbharatirec.nta.ac.in/</u>
- 2. Login with your **Application Number and Date of Birth** and enter Security Pin as displayed and Submit.
- 3. Click on 'Click here to View your Responses' link to view your response sheet.
- 4. Click on 'Challenge of Questions' tab for challenging the questions.
- 5. You will see the Question IDs in sequential order.
- 6. The ID next to the question under the column 'Correct Option' stands for the most appropriate Answer Key to be used by NTA.
- 7. If you wish to challenge this option, you may use any one or more of the Option IDs given in the next four columns by clicking the check box.
- 8. You may upload supporting documents in the field 'Choose File' and upload (all documents to be put in a single pdf/jpg file).
- 9. After clicking your desired option, click on 'Challenge Question' and move to the next screen.
- 10. You will see a display of all the Option IDs you have challenged and if any changes required, candidate can click on Edit/Add challenge Questions Click on 'Save your Claim and Pay Fee Finally'.
- 11. Click on 'Continue and Pay Fee Finally'.
- 12. Select Mode of Payment and Pay a non-refundable processing fee @ ₹ 200/for each question challenged. Make payment through Credit Card/ Debit Card/Net Banking/UPI.
